

MASTER PRICE AGREEMENT

This Master Price Agreement (“**Agreement**” or “**Master Price Agreement**”) is made by and between **T-Mobile USA, Inc.** as contracting agent on behalf of the applicable T-Mobile affiliated entities providing the Products and Services (“**Vendor**”) with principal offices located at 12920 – S.E. 38th Street, Bellevue, WA 98006, and the **League of Oregon Cities (“LOC”)** with principal offices located at 1201 Court St. NE, Suite 200, Salem OR 97301. Where the Agreement refers to “**Party**” or “**Parties**” such designation shall apply to Vendor and/or LOC, as applicable.

WHEREAS, LOC is a governmental entity that enters into arrangements for the purchase of products and services for the benefit of Eligible Members (defined below);

WHEREAS, Vendor wishes to provide to Eligible Members its Products and Services as delineated in this Agreement; and

WHEREAS, LOC desires to promote Vendor’s Products and/or Services to Eligible Members pursuant to the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and sufficient consideration, the receipt and adequacy of which is hereby acknowledged, the Parties hereto agree as follows:

1. GENERAL.

1.1 Applicability. This Agreement contains: (i) general provisions that apply to all Products and Services that the Eligible Member purchases from Vendor; and (ii) provisions that only apply to the rights and obligations of Vendor and LOC relating to the administration of the Agreement. Eligible Members are specifically excluded and shall have no rights or obligations under provisions where the express intent of the provision is to apply solely to LOC. Each government Eligible Member (procuring party) shall be solely responsible for the ordering of Products and Services under this Agreement. A non-procuring party shall not be liable in any fashion for any violation by a procuring party, and the procuring party shall hold non-procuring parties or unrelated purchasing parties harmless from any liability that may arise from action or inaction of the procuring party.

A. LOC, in cooperation with National Purchasing Partners Government Division (NPPGov), entered into this Agreement on behalf of other government agencies that desire to access this Agreement to purchase Products and Services.

B. In addition to the Eligible Member Enrollment Form required under **Section 5.1**, each Participating Agency/Eligible Member is required to execute an Intergovernmental Cooperative Purchasing Agreement (“IGA”), as set forth on the NPPGov web site, www.nppgov.com.

1.2 “Agreement” refers to this Master Price Agreement, including all Attachments, documents incorporated by reference, and related Order(s). Other capitalized terms are defined in this Agreement or the applicable Product-specific Terms posted at <https://www.t-mobile.com/business/terms-and-conditions> (“**Product-Specific Terms**”).

- 1.3 Order of Precedence.** In the event of a conflict within the documents that form the Agreement, the following order of precedence will apply: (i) this Agreement; (ii) the Attachments; the (iii) executed Eligible Member’s Enrollment Form; and (iv) the Product-Specific Terms. If a conflict exists among provisions within the Agreement, specific terms will control over general provisions, and negotiated, added or attached terms, conditions or pricing will control over standardized, posted or non-negotiated terms, conditions and pricing.
- 1.4** This Agreement meets the public contracting requirements of LOC and may not be appropriate under or meet Participating Agencies’ procurement laws. Participating Agencies are urged to seek independent review by their legal counsel to ensure compliance with all local and state solicitation requirement.
- 1.5** LOC acknowledges and consents to the execution of a Vendor Administration Agreement between Vendor and National Purchasing Partners, LLC pursuant to the terms of the RFP for the provision of certain administrative and marketing activities by NPPGov on behalf of LOC.

2. TERM OF THE AGREEMENT.

- 2.1** The term of the Agreement is four (4) years (“**Term**”), beginning on the Effective Date (as defined below).
- 2.2** Upon mutual written agreement of the Parties, Vendor and LOC may extend the Term of this Agreement for one (1) additional one-year renewal term (referenced as Term throughout this Agreement) with at least 90 days written notice from LOC before the initial Term expires. Vendor reserves the right to reject the renewal Term by providing at least 60 days written notice to LOC before the initial Term expires.

3. ATTACHMENTS. The following attachments are incorporated into this Agreement (“**Attachment(s)**”):

- Attachment A:** NPPGov T-Mobile Master Pricing List
Attachment B: Eligible Member Enrollment Agreement

4. DEFINITIONS.

- 4.1 Affiliate.** A legal entity that directly or indirectly controls, is controlled by, or is under common control with the Party. An entity is considered to control another entity if it owns, directly or indirectly, more than 50% of the total voting securities or other similar voting rights.
- 4.2 Confidential Information.** means non-public information (i) about the Discloser’s business, (ii) given to the Recipient in any tangible or intangible form for Recipient’s use in connection with this Agreement or discussions, negotiations or proposals related to any contemplated business relationships between the parties, and (iii) that the Recipient knows or reasonably should know is confidential because of its legends, markings, the circumstances of the

disclosure or the nature of the information. Confidential Information includes, but is not limited to: trade secrets; financial information; technical information, including research, development, procedures, algorithms, data, designs, and know-how; business information, including operations, planning, marketing plans, and products; and the pricing and terms of this Agreement including related discussions, negotiations and proposals.

4.3 Corporate-Liable. Corporate-Liable means an Active Unit (a) activated by Eligible Member for Eligible Member's end use, (b) enrolled in a Business Plan, and (c) for which Eligible Member is financially liable.

4.4 Discloser. Means the party disclosing Confidential Information.

4.5 Eligible Member. Eligible Member is defined in **Section 5.2**. The meaning of "Customer" and "Eligible Member" are interchangeable in the Agreement or Attachments or on websites when Eligible Member is purchasing or using Products or Services from Vendor. If LOC purchases Products and Services under this Agreement as an Eligible Member, LOC shall be deemed a Customer under this Agreement, including but not limited to, under **Attachment B**.

4.6 Effective Date. Is the date the last party signs this Agreement.

4.7 Employee. A person in the service of Eligible Member: (i) from whom Eligible Member withholds FICA (Federal Insurance Contributions Act) contributions from such person's gross pay; or (ii) in any of the following professions in a volunteer capacity: (A) fire fighter; (B) police officer; or (C) emergency medical technician/paramedic.

4.8 Individual-Liable. An Active Unit activated by an Employee or Retiree or Non-Profit Member and for which the Employee or Retiree or Non-Profit Member is financially responsible.

4.9 "Lead Contracting Agency" shall mean the League of Oregon Cities, which is the governmental entity that issued the Request for Proposal ("**RFP**") and awarded this resulting Master Price Agreement.

4.10 "National Purchasing Partners" or "(NPP)" is a subsidiary of two nonprofit health care systems. The Government Division of NPP, herein after referred to as "**NPPGov**", provides group purchasing marketing and administrative support for governmental entities within the membership. NPPGov's membership includes participating public entities across North America.

4.11 Non-Profit Member. A person who is a member of a non-profit organization that qualifies as an Eligible Member and who validates their membership status as a member of the non-profit organization by providing credentials evidencing membership status from Eligible Member.

4.12 Non-Profit Member-Liable. An Active Unit activated by a Non-Profit Member and for which the Non-Profit Member is financially responsible. If a Non-Profit Member purchases Products and Services under this Agreement as an Eligible Member, such Non-Profit

Member shall be deemed a Customer under this Agreement, including but not limited to, under **Attachment B**.

4.13 Order or Purchase Order. A written, electronic or verbal order, or purchase order, submitted or confirmed by Eligible Member and accepted by Vendor, which identifies specific Products and Services, and the quantity ordered. Verbal Orders are deemed confirmed upon Customer's written acknowledgement, or use, of Products or Services. The terms and conditions in any Customer-generated order template will have no force or effect other than to denote quantity, the products or services purchased or leased, delivery destinations, requested delivery dates and any similar information mutually agreed to by the parties.

4.14 Order Term. The term designated for an individual Order.

4.15 Participating Agency. Governmental entities or non-profits that are eligible to be members of NPPGov.

4.16 Product(s). Includes equipment, devices, software, hardware, cabling or other materials sold or leased to Eligible Member by or through Vendor under this Agreement as a separate item from or bundled with a Service.

4.17 Product-Specific Terms. Refers to separate descriptions, terms and conditions for certain non-regulated Products and Services, as posted at <https://www.t-mobile.com/business/terms-and-conditions>.

4.18 Recipient. Means the party receiving Confidential Information.

4.19 Retiree. A person who has retired from an Eligible Member and who validates their status as a retiree by providing credentials evidencing retiree status from Eligible Member.

4.20 Retiree-Liable. An Active Unit activated by a Retiree and for which the Retiree is financially responsible.

4.21 Service(s). Wireless business communications services, including basic or telecommunications services, information or other enhanced services, and professional services provided to Customer by or through Vendor under this Agreement, excluding Products.

5. ELIGIBLE MEMBER PROVISIONS.

5.1 Eligible Member Agreement. Vendor will offer the Products and Services to Eligible Members pursuant to the terms and conditions set forth in **Attachment B** (the "**Eligible Member Enrollment Agreement**"). Eligible Members may participate in this Agreement by ordering Products and Services pursuant to Vendor's standard ordering procedures, subject to Vendor's written acceptance, which includes signing the Eligible Member Enrollment Agreement, and such other applicable Order form(s) designated by Vendor.

5.2 Eligible Member Classification.

A. "Eligible Member" is a member that is either:

1) a governmental entity that is a member of NPPGov or is eligible to be a member of NPPGov, with the exception of federal entities, and also meets one of the following categories:

a) i) Fire Service; ii) Law Enforcement; iii) First Responders; (iv) State, Local and Municipal entities; v) Publicly funded Higher Education or Publicly or Privately funded K-12 schools.

2) a non-profit organization that is a member of NPPGov.

3) Universities and Colleges that are technically for-profit degree-granting institutions.

Vendor reserves the right to not supply services to members that do not meet the criteria specified in this Section 5.2, or members governed by existing federal government, state and local government or commercial agreements with Vendor.

B. The Eligible Members shall be limited to entities meeting the classes of trade requirements of Section 5.2 A above ("**Class of Trade**"). Such Eligible Members shall have the right to purchase or lease Products and Services in accordance with this Agreement. The list of Eligible Members (the "**Membership Roster**") may be amended by LOC from time to time provided any updates to the Membership Roster are consistent with the Class of Trade. The Parties acknowledge that Eligible Members may include entities/facilities located throughout the United States and its territories, including without limitation Puerto Rico. Vendor may stop providing the pricing set forth herein to entities removed from the Membership Roster within thirty (30) days following the applicable date of removal set forth in the Membership Roster.

5.3 Eligible Member Existing Contract. Eligible Members currently under contract with Vendor for like product and services may request that Vendor permit Eligible Member to terminate its existing contract without liability and instead participate in the group purchasing arrangement set forth in this Agreement. Vendor will consider these requests on an individual case basis, provided that the Eligible Member is in good standing. Final determination of such request is at Vendor's sole discretion.

5.4 Survivorship of Eligible Member. In the event the term of the Eligible Member Enrollment Form extends beyond the termination or expiration date of this Agreement, the Eligible Member Agreement's terms and conditions shall continue to apply until such time T-Mobile provides notice to Eligible Member.

5.5 Eligible Member agrees that Vendor and LOC may agree to amend this Agreement throughout the Term by mutual consent provided that all amendments are made in writing and signed by authorized officials of the parties.

5.6 Audit Rights.

A. Vendor Audit Rights.

(1) Regarding Eligible Member. Vendor reserves the right to audit Eligible Members on the Membership Roster from time to time to verify eligibility, including, but not limited to, that each Eligible Member is in the Class of Trade defined in Section 5.2.B. Upon review of an Eligible Member, Vendor may require additional verification from an Eligible Member or LOC regarding the status of the Eligible Member. Upon a determination the Customer does not meet the requirements of an Eligible Member, Vendor may cease applying the Corporate-Liable and/or Individual-Liable Service Pricing Discount.

(2) Regarding Employees, Retirees and Non-Profit Members of Eligible Member. Vendor reserves the right to audit Employees, Retirees and Non-Profit Members from time to time who qualify as an Individual-Liable under this Agreement by verifying Employee's employment with the Eligible Member or Retiree status or Non-Profit Member status. Upon the Employee's termination of employment with Eligible Member, Vendor may cease applying the Individual-Liable Service Pricing Discount. Upon the Non-Profit Member's termination of membership with Eligible Member, Vendor may cease applying the Individual-Liable Service Pricing Discount.

6. RATES AND DISCOUNTS.

6.1 Services Pricing. Eligible Members will receive the discounts ("**Discounts**") and rates on Services as set forth in the pricing Attachments.

6.2 Fixed Rates. Fixed rates and percentage Discounts will remain fixed for the Term. Rates, discounts and pricing not fixed in the pricing Attachments will be based on the then-current list price at the time of purchase or lease, as applicable. If pricing in this Agreement is stated only as a percentage discount off a rate or price appearing in a referenced price list, the percentage discount is fixed for the Term, but Vendor may modify the underlying rate or list price to which the percentage discount is applied on no less than one day's notice.

6.3 Credit Approval. LOC acknowledges that Vendor is not obligated to provide Products and/or Services to an Eligible Member that does not at any time satisfy Vendor's credit criteria.

7. RESERVED.

8. USE OF NAME, SERVICE MARKS, TRADEMARKS. Neither Party will use the name, service marks, trademarks, or carrier identification code of the other Party or any of its Affiliates for any purpose without the other Party's prior written consent. Notwithstanding the foregoing and subject to LOC's written consent with respect to each use, Vendor may use the LOC's name and contact information as a customer reference and may illustrate in a press release, advertising or written or video testimonial the applications and corresponding business benefit of the solution delivered by Vendor.

9. CONFIDENTIAL INFORMATION

9.1 Nondisclosure. Neither Party will disclose the other Party's Confidential Information to any third party, except as expressly permitted in this Agreement. This obligation will continue until 2 years after this Agreement terminates or expires. The Recipient may disclose Confidential Information to its Affiliates, agents and consultants with a need to know, if they are not competitors of the Discloser and are subject to a confidentiality agreement at least as protective of the Discloser's rights as this provision. In addition, either party may disclose this Agreement to an entity that is an Affiliate of LOC on the Effective Date, provided that the Affiliate has signed (a) a separate service agreement with Vendor containing nondisclosure obligations or (b) a non-disclosure agreement reasonably acceptable to Vendor and LOC. The Parties will use Confidential Information only for the purpose of performing under this Agreement or for the provision of other Vendor services. The foregoing restrictions on use and disclosure of Confidential Information do not apply to information that: (A) is in the possession of the Recipient at the time of its disclosure and is not otherwise subject to obligations of confidentiality; (B) is or becomes publicly known, through no wrongful act or omission of the Recipient; (C) is received without restriction from a third party free to disclose it without obligation to the Discloser; (D) is developed independently by the Recipient without reference to the Confidential Information; (E) is required to be disclosed by law, regulation, or court or governmental order; or (F) is disclosed with the prior written consent of the Discloser. Notwithstanding any of the foregoing, provided, Vendor is not obligated to provide notice of required disclosures that pertain to end-user customer information and that are disclosed in response to lawful U.S. process and/or as may be required by state and federal law, nor is Vendor obligated to seek protective orders or similar protection for any such disclosures.

9.2 Injunction. The parties acknowledge that the Recipient's unauthorized disclosure or use of Confidential Information may result in irreparable harm. If there is a breach or threatened breach of this Agreement, the Discloser may seek a temporary restraining order and injunction to protect its Confidential Information. This provision does not limit any other remedies available to either party. The party who has breached or threatened to breach its nondisclosure obligations under this Agreement will not raise the defense of an adequate remedy at law.

9.3 Privacy. Vendor's privacy policy, as amended from time to time, is available at [T-Mobile Privacy Center | Privacy Policies & Data Controls](#). The privacy policy includes information about Vendor's customer information practices and applies to the provisioning of the Products and Services.

10. LIMITATIONS OF LIABILITY.

10.1 Damage Limitations. Each Party's maximum liability for damages caused by its failure(s) to perform its obligations under this Agreement is limited to: proven direct damages for all claims arising out of this Agreement not to exceed the total net payments of Administrative Fees paid by Vendor to NPPGov under the Vendor Administration Agreement during any twelve (12) month period during the Term or any renewal term of this Agreement.

10.2 NEITHER PARTY WILL BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, OR INDIRECT DAMAGES FOR ANY CAUSE OF ACTION, WHETHER IN CONTRACT OR TORT. CONSEQUENTIAL, INCIDENTAL, AND INDIRECT DAMAGES INCLUDE, BUT ARE NOT LIMITED TO, LOST PROFITS, LOST REVENUES, AND LOSS OF BUSINESS OPPORTUNITY,

WHETHER OR NOT THE OTHER PARTY WAS AWARE OR SHOULD HAVE BEEN AWARE OF THE POSSIBILITY OF THESE DAMAGES.

11. INDEMNIFICATION.

11.1 Vendor will indemnify and defend LOC, its directors, officers, employees, agents and their successors against all third party claims for damages, losses, liabilities, or expenses, including reasonable outside attorney's fees, arising directly from performance of this Agreement and relating to personal injury, death, or damage to tangible personal property that is alleged to have resulted, in whole or in part, from the negligence or willful misconduct of Vendor or its subcontractors, directors, officers, employees or authorized agents.

11.2 Indemnification Procedures. The following procedures will apply to any indemnification obligation under this Section: (a) the Party seeking indemnification will promptly notify the indemnifying Party in writing of any claim or suit; (b) the indemnifying Party will have sole control of the defense or settlement; provided, however, that the indemnifying Party will not enter into any settlement that obligates the Party seeking indemnification to make an admission of guilt or incur any expense for which the Party seeking indemnification is not indemnified, without such Party's prior written consent, which will not be unreasonably withheld; (c) the Party seeking indemnification will have the right to be represented separately by counsel of its own choosing, at its own expense, in connection with any claim or suit; and (d) the Party seeking indemnification will provide reasonable cooperation to the indemnifying Party at the indemnifying Party's expense; (e) in the event an indemnified Party does not provide prompt notice to the indemnifying Party, indemnification will be withheld only to the extent the indemnifying Party was adversely prejudiced by such delay in notice; and (f) the indemnifying Party must hire qualified and competent counsel.

11.3 Exclusive Remedies. The provisions of this Indemnification Section state the entire liability and obligations of the indemnifying Party and any of its Affiliates or licensors, and the exclusive remedy of the indemnified Party, with respect to any of the claims identified in this Section.

12. TERMINATION.

12.1 Vendor Right to Terminate LOC.

- A.** Vendor may terminate this Agreement with LOC upon written notice:
 - (i) For cause, if LOC fails to cure any other material breach of this Agreement within 30 days after receiving Vendor's written notice; or
 - (ii) For convenience, by providing 90 days' written notice to LOC.
- B.** If Vendor terminates this Agreement under this Vendor Right to Terminate LOC section, the termination or survival of existing Eligible Member Enrollment Forms shall be determined in accordance with the Term section of the applicable Eligible Member Enrollment Form and Section 5.4 above.
- C. Individual Liable.** Individual Liable Active Units are subject to the order term requirements and other obligations in the separate consumer subscriber agreement between Vendor and the Employee or Retiree.

12.2 LOC Right to Terminate.

- A.** LOC may terminate this Agreement with Vendor upon written notice:
 - (i) For cause, if Vendor fails to cure any other material breach of this Agreement within 30 days after receiving LOC's written notice; or
 - (ii) For convenience, by providing 90 days' written notice to Vendor.
- B.** If LOC terminates this Agreement under this LOC Right to Terminate section, the termination or survival of existing Eligible Member Enrollment Forms shall be determined in accordance with the Term section of the applicable Eligible Member Enrollment Form and Section 5.4 above.
- C. Individual Liable.** Individual Liable Active Units are subject to the order term requirements and other obligations in the separate consumer subscriber agreement between Vendor and the Employee or Retiree.

12.3 Vendor Right to Suspend or Terminate Eligible Member. Vendor and Eligible Member's rights to terminate an individual Eligible Member Agreement is articulated in the terms and conditions provided in the Eligible Member's Agreement.

13. FORCE MAJEURE. Neither party will be responsible for any delay, interruption or other failure to perform under this Agreement due to acts, events or causes beyond the reasonable control of the responsible party (a "Force Majeure Event"). Force Majeure Events include, but are not limited to: natural disasters (e.g., lightning, earthquakes, hurricanes, floods); wars, riots, terrorist activities, and civil commotions; inability to obtain parts or equipment from third party suppliers; cable cuts by third parties, a local exchange carrier's activities, and other acts of third parties; explosions and fires; embargoes, strikes, and labor disputes; and governmental decrees.

14. MISCELLANEOUS.

14.1 Compliance with Law. Each party agrees that it will comply with all applicable laws in performance of its obligations under this Agreement.

14.2 No Waiver of Rights. The failure to exercise any right under this Agreement does not constitute a waiver of the party's right to exercise that right or any other right in the future.

14.3 Governing Law. This Agreement will be governed by the laws of Oregon, without regard to its choice of law principles. Each Enrollment Agreement will be governed by and construed in accordance with the laws in which the Service is provided to Eligible Member, without regard to its choice of law principles. The English version of this Agreement will prevail over any foreign language versions.

14.4 Dispute Resolution.

- A. Jury Trial Waiver.** The parties mutually, expressly, irrevocably and unconditionally waive trial by jury and any right to proceed as lead plaintiff, class representative, or other representative capacity for any class action proceedings arising out of or

relating to this Agreement or an Order. This subsection survives the termination of this Agreement.

- B. Arbitration.** If the parties mutually agree, any dispute arising out of or relating to the Agreement may be finally settled by arbitration, including claims relating to the negotiations and the inducement to enter into the Agreement. However, if the jury trial waiver is held to be unenforceable by a court, then arbitration is mandatory. Any arbitration must be held in accordance with the rules of the CPR Institute for Dispute Resolution and governed by the United States Arbitration Act, 9 U.S.C. Sec. 1, et seq. All arbitration proceedings for disputes relating to Domestic Products or Services will be held in the Bellevue, WA metropolitan area. If the dispute relates to Vendor's provision of non-Domestic Products or Services, all arbitration proceedings will be conducted in the English language pursuant to the Rules of Conciliation and Arbitration of the International Chamber of Commerce. The place of arbitration for disputes related to non-Domestic Products or Services is New York, NY, USA. No arbitration proceeding will include class action arbitration.

14.5 Assignment.

- A.** LOC or Vendor may not assign any rights or obligations under this Agreement or any Order without the other party's prior written consent, such consent not to be unreasonably withheld, conditioned or delayed, except that LOC or Vendor may assign this Agreement, upon written notice, to an Affiliate or an entity that has purchased all or substantially all of the assigning party's assets.

14.6 Independent Contractors. The Parties' relationship hereunder is that of independent contractors. This Agreement does not create any employment, agency, franchise, joint venture, partnership or other similar legal relationship between Vendor and LOC. Neither party has the authority to bind or act on behalf of the other party except as otherwise specifically stated herein.

14.7 Third Party Beneficiaries. This Agreement is not intended to and does not create any third party beneficiaries, other than Eligible Members to the rights and obligations as set forth herein, nor shall any third party beneficiaries be interred by operation or otherwise.

14.8 Amendments/Alterations. This Agreement may only be amended in a writing signed by both parties' authorized representatives. Alterations to this Agreement are not valid unless accepted in writing by both parties.

14.9 Notice. Notices required under this Agreement must be submitted in writing to any address listed in this Agreement for the other party or, for notices to LOC, to the address Vendor uses for shipping or billing or as set forth in an Order. In the case of a dispute, notices also must be sent to:

14.10 Severability. If any provision of this Agreement is found to be unenforceable, this Agreement’s unaffected provisions will remain in effect and the parties will negotiate a mutually acceptable replacement provision consistent with the parties’ original intent.

14.11 URLs and Successor URLs. References to Uniform Resource Locators (URLs) in this Agreement include any successor URLs designated by Vendor.

14.12 Survivability. The terms and conditions of this Agreement regarding confidentiality, indemnification, warranties, dispute resolution are intended to survive the expiration of this Agreement.

14.13 New Technology. Consistent with the intent of the RFP, the parties agree to allow for future industry and technology advances. Accordingly, as Vendor makes new products and services generally commercially available to the public, at Vendor’s sole option such new products and services may be offered under this Agreement.

14.14 Insurance.

- A.** During the term of this Agreement, Vendor shall maintain at its own cost and expense (and shall cause any subcontractor to maintain) insurance policies providing insurance of the kind and in the amounts generally carried by reasonably in the industry, with one or more reputable insurance companies authorized to do business in Oregon and any other state or jurisdiction where Products and Services are sold hereunder. Such certificates of insurance shall be made available to the Lead Contracting Agency upon written request. BY SIGNING THE AGREEMENT VENDOR AGREES TO THIS REQUIREMENT AND FAILURE TO MEET THIS REQUIREMENT WILL RESULT IN CANCELLATION OF THIS AGREEMENT.
- B.** All insurance required herein shall be maintained in full force and effect until all work or service required to be performed under the terms of this Agreement is satisfactorily completed and formally accepted. Any failure to comply with the claim reporting provisions of the insurance policies or any breach of an insurance policy warranty shall not affect coverage afforded under the insurance policies to protect the Lead Contracting Agency. The insurance policies may provide coverage that contains deductibles or self-insured retentions. Vendor shall be solely responsible for the deductible and/or self-insured retention.

- C. Vendor shall carry Workers' Compensation insurance to cover obligations imposed by federal and state statutes having jurisdiction over Vendor's employees engaged in the performance of the work or services, as well as Employer's Liability insurance. Vendor waives all rights against the Lead Contracting Agency and its agents, officers, directors and employees for recovery of damages to the extent these damages are covered by the Workers' Compensation and Employer's Liability or commercial umbrella liability insurance obtained by Vendor pursuant to this Agreement.
- D. Insurance required herein shall not be permitted to expire, or be canceled without thirty-days (30-days) prior written notice to the Lead Contracting Agency.

14.15 Entire Agreement. This Agreement, including all referenced Attachments, documents, annexes, exhibits, and related Orders, constitutes the entire agreement and understanding between the parties and supersedes all prior or contemporaneous negotiations or agreements, whether oral or written, relating to its subject matter.

14.16 Pricing Expiration. To become effective, this Agreement must be: (a) signed by an authorized LOC representative; (b) delivered to Vendor and (c) signed by a Vendor officer or authorized designee. Upon expiration of this Agreement or a specific Attachment, Vendor, at its option, may continue to provide some or all of the Products and Services on a month-to-month basis under the terms, conditions and pricing in this Agreement or the applicable Attachment, excluding minimum commitments, or, with advance notice, at standard list pricing, until either party provides 30 days' advance written notice to terminate.

14.17 Technology Evolution.

A. In the normal course of technology evolution and enhancement, Vendor continually updates and upgrades its networks, Products and Services. In some instances, these efforts will result in the need to ultimately replace or discontinue certain offerings or technologies. In such event, Vendor will undertake such efforts in a customer-focused and commercially reasonable manner. Accordingly and notwithstanding anything in this Agreement or Enrollment Agreement to the contrary, Vendor reserves the right, in its sole discretion, after providing the notice set forth in subsection B below, to: (1) migrate a Customer to a replacement technology; or (2) discontinue any Product, Service, business plan, network standard or technology, without either party being in breach of the Agreement or incurring early termination liability relating to the discontinuance of the affected Product, Service, business plan, or network.

B. If Vendor takes any action set forth in subsection A above, Vendor will provide advance notice reasonably designed to inform each affected Customer of such pending action. The form of Vendor's notice may include without limitation, providing written notice to any address listed in the Enrollment Agreement for Customer or any address Vendor uses for billing or as set forth in an Order. Customer and each Eligible Member agrees that such notice is reasonable and sufficient notice of Vendor's pending action.
